

iii) For the sake of clarity, it is hereby stated that all the objectives could be carried out for the benefits of public at large, irrespective of caste creed religious and sex.

c) Relief to the Poor:

- i) To assist and provide for the poor by constructing community halls, Rest houses, dormitories, wells, tube wells, drinking water facilities etc to conduct the feeding of the poor and to give food clothing and cash grants to the poor, to grant donations to the support of the inmates of orphanages rescue and rehabilitation centers and similar institutions. The poor may also be assisted by way of teaching of crafts, engineering and similar skills and industrial training including on the job training.
- ii) To undertake, carry out, promote and sponsor rural development including any programs for the promoting the social and economic welfare and upliftment of the public and to incur any expenditure on any programs of rural development programs and to assist in the executing and promoting thereof either directly or through any agency or in any other manner.
- iii) To give, provide and/or render help and assistance to and or implement any schemes for providing livelihood and upliftment of the poor.
- iv) To take all out efforts to provide shelter to the homeless in rural and slum areas.
- v) To give, sponsor, provide food, medicine and other help and/or assistance in any shape or form to the poor and needy.
- vi) To give provide and/or render monetary and/or other help, start, maintain and assist in any relief of persons and animals affected by natural and other calamities such as flood, fire, earthquake, storm, accident, drought, subscription or contribution to institutions, establishments, centers which enjoy recognition under section 80G of the Income Tax Act 1961 or persons doing relief work on such occasions.

- viii) To acquire, fund, promote or assist in cash or kind for conducting marriages of the poor or needy.

d) Other objects

- i) To establish, run and aid free public reading rooms and libraries.
- ii) To contribute for the construction of any community hall, hostel, boarding house, library reading rooms ,wedding hall to be provided free to the poor and deserving any entrepreneurship which empowers rural women folk to complete with and raise their standard of life on par with others in general by providing self-employment schemes be fitting the rural environment through establishing tailoring institute, candle industries, garment industries, Agro based income generating work like mushrooming and cottage industries etc., thus enabling them stand on their own to face the life situations to take all steps and assist for the empowerment of women folk both in rural semi urban and urban areas.
- iii) To help, assist, contribute in cash or kind, to any association, institution or trust which has been granted approval under section 80 G of Income Tax act of 1961, amended from time to time.
- iv) To assist the rural youth by setting up free tuition centers/tutorials/Computer trainings for the less privileged to equip and enlarge them to acquire confidence to compete with the urban lot. So as to face the competitive exams of all India level both private and government. So that even the rural youth coming from villages can raise their head to occupy the elite position like IAS, IPS, Software Professionals, Army Officers and Scientist.

However surplus if any arising out of the any of the activities of the Trust will be reinvested solely for the attainment of the objectives of the Trust and will not be distributed either directly or indirectly for the benefit of the Trustees.

4. FUNDS, INCOME etc.:

On behalf of the Trust, the Trustees may accept donations, grants, subscriptions, aids, or contributions from any person, organizations, Government, Local Authorities or any other charitable Institutions, in cash or in kind including immovable property, but the Trustees shall not accept any receipt with any condition or terms inconsistent with objects of Trust. While applying such receipt to the objects, the Trustees shall respect the directions, if any, by the grantor/donor. Any receipt with the specific direction to Trust the same part of the corpus of the trust or separate fund shall be funded accordingly.

The funds and the income of the Trust shall be solely utilized for the achievement of its objectives and no portion of it shall be utilized for payment of the Trustees by way of profit, interest, dividends, etc.

5. INVESTMENTS:

All monies, which shall not immediately, required for the current needs shall be invested by the Trustees in eligible securities and investments, or in banks etc. as per the provisions and modes specified under the provisions of section 13 (1) (d) r.w.s 11(5) of the Income Tax Act, 1961, as amended from time to time.

6. TRUSTEES:

- The number of the Trustees shall at no time be less than Two or more than Fifteen constituting the Board of Trustees, which may be altered from time to time by the Board of Trustees.

8. POWER OF OFFICE OF THE TRUSTEES:

- The Trustees shall have the power to determine, in case of doubts, whether money received for the time being be considered as capital or income and whether out of the income or capital any expenses or outgoings shall be incurred or opt to be paid or borne and only every such determination shall be binding and conclusive, provided that nothing herein contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust Fund for any purpose not authorized by these present.

In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstance be distributed among the Trustees, Members of Managing Committee or Members of Governing Body, but the same shall be transferred to another Charitable Trust, Society, Association, Foundation or Institutions, whose objects are similar to those of this Trust and which shall enjoy recognition U/s 80G of the Income Tax Act.
12. No amendment to this Trust Deed or rules and regulations shall be made which prove to be repugnant to the provisions of sections 2(15), 11,12 and 13 of the Income Tax Act, 1961 as amended from time to time and further, no amendment shall be carried out without the prior approval of the Director of Income Tax (Exemptions).
